Trinity Fields is a Rights Respecting School

Trinity Fields is a Rights Respecting School and we are committed to the principles and values of the United Nations Convention on the Rights of the Child (UNCRC) across all areas of our work.

Trinity Fields is a school where pupils are at the heart of everything we do. As part of our aim to promote a happy and successful school we have successfully been awarded UNICEF’s “**Rights Respecting School Award**” (January 2017).

The ‘Rights Respecting School’ Award (RRSA) helps our pupils become more confident, caring and as independent as possible both in school and within the wider community. By learning about their rights our pupils, your children, also learn about the importance of respecting the rights of others, that is, their responsibilities.

Our pupils are encouraged wherever possible to reflect on how their behaviour and actions affect those around them, which allows us to build and maintain a positive and safe learning environment for all, both in the classroom and around the school site.

Trinity Fields is a Healthy School

We are also a Healthy School and we take responsibility for maintaining and promoting the health and wellbeing of the Trinity Fields team (pupils, parents/carers, staff, governors etc.). Trinity Fields will continue to develop as a learning organisation to ensure it has the capacity to adapt to and explore a range of new approaches which results in improved outcomes and well-being for all of our pupils.

- Inspirational leaders working collaboratively to raise standards.
- Strong and inclusive schools committed to excellent, equity and well-being.
- Robust assessment, evaluation and accountability arrangements supporting a self-improving system.

Context

Qualified for Life (2014) provides further endorsement of our commitment to being a Rights Respecting School by stating:

"learners are the heart of all that we do" and further "every child and young person benefits from personalised learning".

Successful Futures (2015) also states that:

"Each child and young person in Wales should be able to benefit from curriculum and assessment arrangements that will best meet their present needs and equip them for their future lives. Our children and young people only have a relatively short time at school. We must use that time judiciously and productively to help each one of them to grow as a capable, healthy, well-rounded individual who can thrive in the face of unknown future challenges".

At Trinity Fields School and Resource Centre we acknowledge the importance of sun protection and want staff and pupils to enjoy the sun safely.

Aims of policy

The key aims of this policy are to teach pupils, staff and parents/carers about effective sun protection in each of the 3 main areas:

1. **PROTECTION:** providing an environment that enables pupils and staff to stay safe in the sun.

2. **EDUCATION:** learning about sun safety to increase knowledge and influence behaviour.
3. **COLLABORATION:** working with parents/carers, school staff and the wider community to reinforce awareness about sun safety.

How we will keep our pupils safe in the sun

1. Staff will provide information to pupils, wherever appropriate about the dangers of exposure to the sun.
2. Parents and carers will be sent a letter explaining what the school is doing about sun protection and how they can help at the beginning of the summer term.
3. When the sun is strong staff will ensure pupils wear sun protection cream before they go out to play at breaktimes/lunchtimes or participate in outdoor lessons.
4. Wherever possible, pupils will be encouraged and supported to independently apply sun cream. Parents/carers will be asked to sign consent for staff to support pupils' use of sun cream or apply directly where pupils are unable to do this for themselves. A copy of the letter will be found in **Appendix 1**.
5. Pupils will always be encouraged to wear sun hats if exposed to the sun for any prolonged period of time. Parents/carers will be asked to send in appropriate clothing, hats and sun cream for their child's use.
6. Pupils will be encouraged to play in the shade. Appropriate shaded areas are available in all play areas. Where pupils insist on playing in the sun they will remain outside for reduced periods of time.
7. In the summer months we will aim to schedule outside activities, school trips and PE lessons before 11.00 am wherever possible. If this is unavoidable we will ensure hats, clothing and sun screen are all worn to prevent sunburn.
8. The school leadership team will audit our arrangements as necessary.

Policy review

Responsibility for the success of our work-life balance strategy lies with the Governing Body and with each employee. In light of the ongoing and rapid developments within Welsh education this policy will be reviewed on a regular basis to ensure that it reflects current legislation and best practice.

Appendix 1: letter to be sent to parents/carers

Dear Parents/Carers,

Now the summer term has started, I wanted to write and tell you about our **sun protection policy**. We have developed this with the help of parents/carers, teachers and pupils to ensure that we can all enjoy the sun safely over the coming months.

The sun's rays are particularly strong over the summer and they can damage children's skin. This may not seem like a problem right now, but it can lead to health issues in later life. Your child's health and well-being are very important to us, which is why we have decided to:

- Increase the amount of school time spent learning about sun protection.
- Provide shade areas in the playgrounds.
- Encourage pupils to wear hats and t-shirts when outside.
- Encourage pupils to use at least SPF 15 sunscreen in summer months.

I have also included a Sun Smart information card which will explain how to keep your child safe from the sun at home. Your support is very important if our new policies are going to work. You can help by:

- Talking to your child about the importance of sun protection at home.
- Sending your child to school with a wide-brimmed hat.
- Signing the slip on your child's Health care plan to ensure staff can support your child apply sun cream.
- Send in a high factor sun cream.

Together I hope we can have a very happy and safe term, enjoying the sun safely.
